For Your RRSP, TFSA and RESP Accounts

November 2021

Maximizing the value of your registered plans by making annual contributions to your Registered Retirement Savings Plan ("RRSP"), Tax-Free Savings Account ("TFSA"), and Registered Education Savings Plan ("RESP") is an important wealth planning strategy. By making your annual contribution(s) early in the year, you'll benefit from the tax-sheltered growth all year long.

TFSA contribution details:

- The current annual TFSA contribution limit is \$6,000. Any unused contribution room from previous years carries forward and can be used in any future year¹.
- You can gift funds to your spouse/common-law partner or adult child to allow them to contribute to their own TFSA (subject to their personal TFSA contribution limit). Income earned within their TFSA will not be attributed back to you.

RESP contribution details:

- There is no minimum annual contribution limit. However, there is a maximum lifetime contribution limit of \$50,000 per beneficiary. The number of years over which contributions can be made to an RESP is 31 years.
- The Canada Education Savings Grant ("CESG") pays 20 per cent of annual contributions per beneficiary to an RESP, up to a maximum of \$500 per beneficiary per year. The maximum lifetime CESG is \$7,200 per beneficiary.
