## Home care services

Arranging home care services for an aging friend or relative can be a confusing process. Many caregivers are not sure what questions to ask to determine if a home care provider is the right one for their situation. The following list of key questions may be useful to consider when arranging home care services and are designed to help you assess and compare providers. If so, who is that person and how do I reach them?
What are the costs for services?
Am I eligible for any costs to be covered by the provincial or federal government (e.g., veteran's benefits)?
How does the provider handle billing and payment?
Does the provider ensure patient confidentiality? How?
