An SMA is an individual investment account where your assets are managed directly by an institutional money manager. The manager purchases securities for you based on a model portfolio, and you own those underlying securities. SMAs are highly customizable and can be very tax efficient.

Advice, Monitoring and Oversight

After working with you to determine your financial needs, objectives and risk tolerance, your Investment Advisor will develop your Investment Policy Statement (IPS). Your IPS will then be used by your Investment Advisor to guide the selection of money managers and the individual investments within your account.

Responsibilities include automatic rebalancing to return your portfolio to its strategic asset mix, intelligent cash management of contributions and withdrawals, enhanced tax management functions and coordinating the trading among your various investment managers.

Reporting

Your Architect statement provides everything you need to keep abreast of your portfolio, all within a single, quarterly report. The reporting package provides performance details, tax information and a full listing of all the securities that make up the account. In addition, your Investment Advisor can provide you with insightful quarterly investment manager commentaries as well as a comprehensive year-end summary documenting the activities that occurred within your account during the past year.

One Comprehensive Fee

Architect uses a tiered structure to determine the annual management fee for your account. The fee will vary depending on the amount invested and the type of assets held in your account. The comprehensive fee covers:
