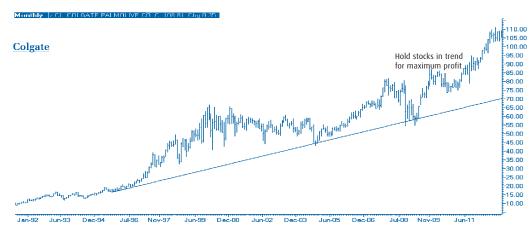

1. Capital Preservation, by actively selling stocks which fall below support levels.

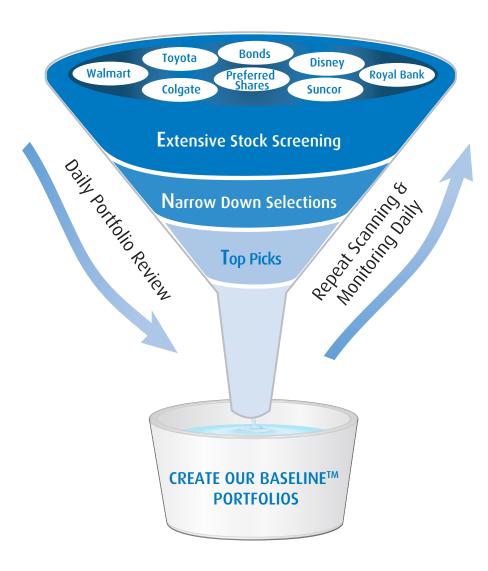


2. Capital Growth, by holding on to winning stocks and maximizing profits.

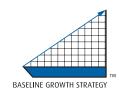
