BMO SmartFolio is an online investment management service for investors looking for a convenient, affordable and professionally managed investment solution. With a minimum initial investment of \$5,000, you'll be matched to a professionally managed model portfolio of BMO exchange-traded funds (ETFs), which will be actively monitored and rebalanced by investment professionals.<sup>1</sup>

BMO SmartFolio is an ideal option for investors who may be just starting their investing program, and do not currently require the complete personalized and sophisticated advice and wealth management services provided by a BMO Nesbitt Burns Investment Advisor, or do not currently meet minimum investment requirements. With BMO SmartFolio, you can set-up and monitor your account through your mobile device or desktop, anytime, anywhere.

And, if you need assistance during any stage of the process, a dedicated BMO SmartFolio team is available by email, phone or live chat to assist you.

Here's what to expect when opening your BMO SmartFolio account.

## An ETF portfolio aligned to your investor profile

During the application process, you'll be asked a series of questions to determine your investment objectives, time horizon and risk tolerance, in order to confirm the BMO SmartFolio portfolio best suited to your investor profile. From here, you'll be presented with a professionally managed model portfolio of BMO ETFs that align to your needs. After you review and accept the recommended portfolio, your funds will be invested accordingly.

## We handle the day-to-day

Once your BMO SmartFolio account is opened, the rest is easy. A team of portfolio managers will actively manage and balance your ETF portfolio to ensure it remains consistent with your investment objectives.

## Track your performance

You can review your account from any mobile device or desktop. Portfolio performance is available as a dollar value, a percentage of dollars invested or in chart format, detailing your portfolio's performance over time. You'll also have access to online statements, which allow you to keep updated on your monthly account balance, as well as all transactions which occurred during the reporting period.

## Available accounts

The following account types are eligible for BMO SmartFolio:

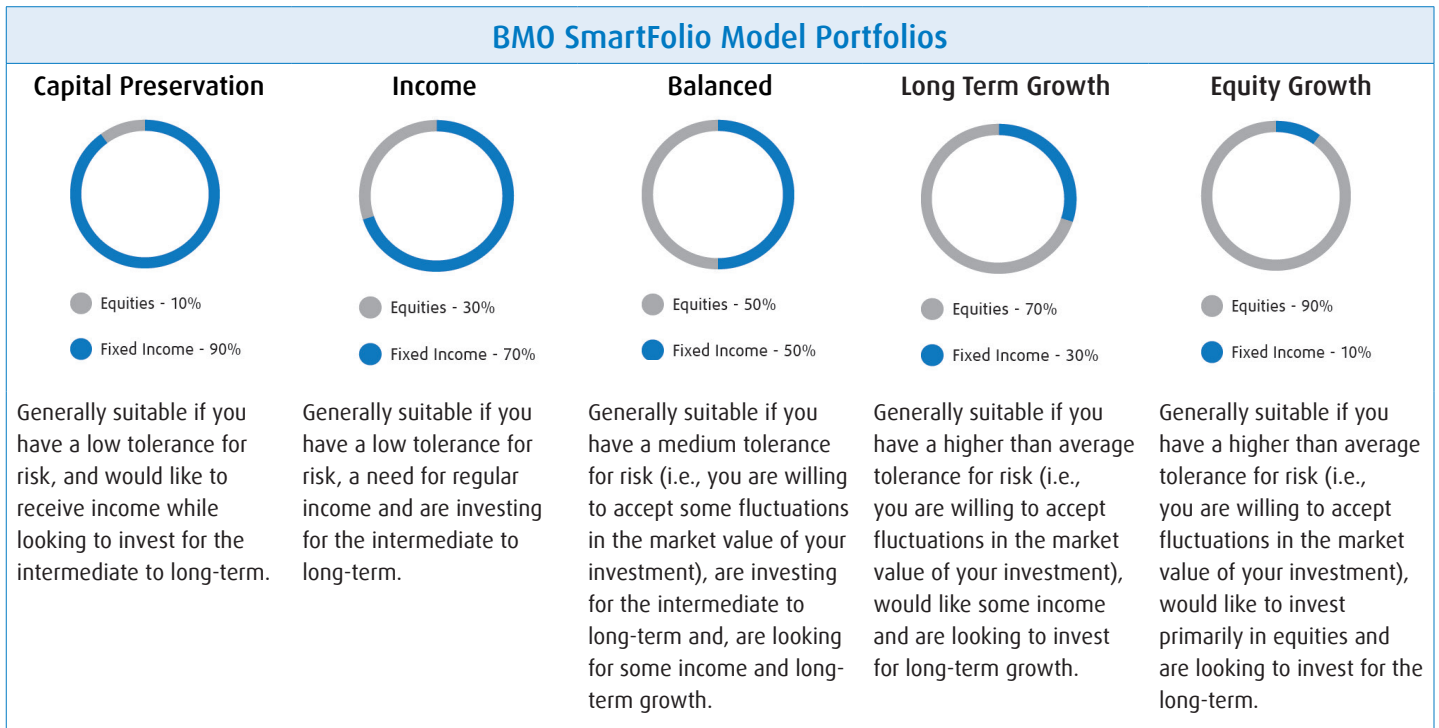
- Individual or joint investment accounts;
- Tax-Free Savings Accounts (TFsAs);
- Registered Retirement Savings Plans (RRSPs) and Spousal RRSPs; and
- Registered Education Savings Plans (RESPs).

Effective June 16, 2017, Registered Retirement Income Funds (RRIFs) will be available through BMO SmartFolio.

## BMO SmartFolio ETF Portfolios

An exchange-traded fund is an investment fund that represents a basket of stocks, bonds or other investments. Unlike mutual funds, an ETF is actively traded on a stock exchange, often tracking a particular market index or may have a specific investment strategy. ETFs can be an attractive investment option as they provide investors with a low cost option to build a well-diversified portfolio.

Individual BMO ETFs are purchased in your BMO SmartFolio portfolio, based on one of the following BMO SmartFolio model portfolios.



## Fees

Your annual BMO SmartFolio advisory fee is calculated as a percentage of the assets in your portfolio and covers all trading costs. The annual advisory fee ranges from 0.7% to 0.4%, depending on your recommended portfolio. And, as your assets grow, your fees are reduced.<sup>2</sup>
